A little background on FIA...Faith in Action was founded in 2004 with a \$35,000 grant received from the Robert Wood Johnson foundation. A community round-table the prior year exposed the need for transportation to medical appointments and treatments as a community need. The organization began small serving approximately 8 clients. Currently FIA serves 102+ per year. The organization is a 501 (c)(3) non-profit funded through grants, fundraisers and donations from churches, businesses, civic organizations and individuals. The program is managed by two, part-time workers, an Executive Director and a contracted Scheduler. All transports are provided by dedicated Valley Health credentialed volunteers.

Faith in Action was presented with a check for \$670.90 raised by Hottel and Willis employees for local charity. Employees contribute to participate in dress down Friday. At the beginning of each quarter, a firm member, selected at random chooses a local charity to be the recipient for that quarter.

Meet the Board of Directors Chair... Karen O. Shipp


Faith in Action has been a part of my life since a group of community minded public servants set around a large table trying to determine the most critical needs of low income individuals in the immediate area. Of course there were many suggestions put forth, but the one that was mentioned the most was a lack of transportation in the area. With financial help from the Robert Woods Johnson Foundation, a steering committee was formed to work out the details for getting Faith in Action off the ground. The mission was to provide free transportation to folks who had no other means of getting to doctor appointments, cancer treatments, dialysis, and other types of medical treatments. So in 2004, Faith in Action began its services to the residents of Winchester, Front Royal, and Strasburg, and Frederick and Clarke Counties. An Executive Director was hired, and volunteer drivers were recruited and trained. So we have been of service to those needing medical transportation for the past 15 years.

My interest in serving on non-profit boards and helping those in need came from watching my parents take on these roles throughout my life. I attended Shepherd College (now University) and graduated with a desire to help others. My first job was at Winchester Social Services where I took on the role of the Adult Services Worker. At that time in 1970, the only service referrals for adults needing social services were the churches and the Salvation Army. I retired in November 2010 from paid employment but continue to enjoy seeing that those in need get a helping hand.

My husband Jim and I have been married for 51 years and have one daughter, Sherry Newman, who is a reading specialist for Clarke County Schools. She was brought up watching her parents leaving in the evenings to attend meetings of a volunteer nature. She took to heart our belief that one must do good for others. Sherry and her husband became foster parents for which there is a tremendous need

In the immediate area. And from that experience, she and her husband and daughter just adopted two little boys ages 3 and 4 who have added so much joy to our lives. She, too, is an active volunteer working for the needs of our children.
